**Re: Fresno Unified School District/Public Records Act Request**

Dear Mr. Webb:

This firm represents the Fresno Unified School District ("District") with respect to your three (3) Public Records Act requests, which were all received by the District on July 27, 2015. This letter serves as the District's initial consolidated response to your requests pursuant to Government Code §6253, subdivision (c).

This office invokes, on the District's behalf, the fourteen (14) day extension of time to respond to your requests pursuant to Government Code §6253(c) (1) and (2) on the grounds that your requests will necessitate the search for and collection of records from locations other than the office processing the requests, and/or on the grounds that your requests will necessitate the search for, collection and examination of a voluminous amount of separate and distinct records.

Therefore, please anticipate transmittal of the District's determination as to the disclosability of the records in its possession that are responsive to your requests, if any, by no later than August 20, 2015.

In addition, in the interest of facilitating the District's processing of your requests, and in accordance with Government Code § 6253.1, the District requests that you provide clarifying information regarding your request for copies of "FUSD's expense reports from January 1<sup>st</sup>, 2012, to July 27, 2015." This request, as written is both vague as to the types of public records sought, and broad with respect to the scope of records sought. Therefore, to the extent possible, the District requests that you provide further information that will describe with greater particularity the specific types of public records that you are requesting, and/or limit the scope of the records being requested.


